#### Introduction


The panel is made of high quality deep stretch coil steel sheet and SPCC steel sheet, which is punched, spot-welded, coated with epoxy powder after has been phosphorated. The panel is filled with foamed cement inside. After being kept for a period of time, it forms a stable support structure. The top sheet is stuck with anti-wear and antistatic HPL. And the panel is installed with stringer and pedestal.







HPL panel with imprinted edge. Collecting both advantages of PVC trim and monolithic edge trim panel, it will be suitable for date center



#### Type 5:

Cornerlock laminate panel is designed for seismic requirement. The system is more rigid because the panel is not only supported by stringer but also lock down to the pedestals. A tailor made round chip of the floor finish material will cover the panel cornerlock holes beautifully.






The main advantage of raised floor is the flexibility. The system can be installed to various finished floor height by diverse pedestal type. Raised floor can be adjusted to level by the pedestal even on a rough surface. And all the pedestal will be anti-corrosion coated.

The pedestal can either be glued or mechanical fixed to the subfloor.

Bolted stringer is recommended for anti-static steel raised floor. It shall benefit both the system stability and the loading performance.

#### 1. The Agent:

The DISTRIBUTOR is hereby appointed as sole agent for the products specified under Clause 3 of this agreement.

#### 2. Territory:

The DISTRIBUTOR is the sole Agent for the territory of Egypt, for the products listed below in clause 3.

#### 3. Products:

The whole range of Access Floors is covered under this agreement. Exclude any specified products manufacturing for international brands.







#### 4. Duration:

- This agreement will take effect on the 1<sup>st</sup> of January 2019 and will remain in force for a period of 3 years from the starting date. Thereafter the performance of the DISTRIBUTOR and the trading partnership would be jointly reviewed. The agreement will be automatically renewed for a new 3 calendar years if it is in the mutual interest of both parties to continue the trading partnership. For major reasons and by mutual agreement, either party in giving to the other a six months notice period can terminate this agreement.
- In the event of gross violation of the principles of this agreement, termination will be immediate and without recourse.

#### 5. The SUPPLIER's Undertakings

- Provide Business development support to the DISTRIBUTOR in terms of promoting Dawn Modular Floor products.
- To provide the DISTRIBUTOR with all Information, Technical Data manuals and product literature.
- Supply Products to the DISTRIBUTOR at the SUPPLIER's Export List Price on agreed discount structure. Price list shall be valid for 6 months. Special prices for special projects shall be discussed and agreed between the two parties on case-by-case basis. In case of raw materials prices increase or decrease two months notes shall be given.
- Provide cover to the DISTRIBUTOR for a period of 24 months warranty period from the date of despatch on Dawn Modular Floor Products against manufacturing defects. Extended warranty can be discussed and agreed upon for special projects.
- In coordination with the DISTRIBUTOR, the Principal will agree on an annual Marketing / Sales plan and a stock profile to support the same.
- It is expressly specified and agreed between the two parties that the SUPPLIER will not practice any kind of direct sales to customers within the territory specified in article-2 .All inquiries which might be received by the SUPPLIER should be forwarded to the DISTRIBUTOR via a specific sales follow-up form, filled by the DISTRIBUTOR and returned to the SUPPLIER explaining briefly the action taken. The SUPPLIER's engineers visiting Egypt will provide the DISTRIBUTOR with all sales and marketing leads and extend any assistance the DISTRIBUTOR may need at DISTRIBUTOR's cost.
- The SUPPLIER will recognize that the DISTRIBUTOR as the preferred route to market within the territory specified in article-2, any enquiries and sales and





marketing leads received on a direct basis by the SUPPLIER will be referred to the DISTRIBUTOR via a specific sales follow-up form and extend any assistance to the DISTRIBUTOR. In instances where the client may also operate as the principal contractor the SUPPLIER will use best endeavors to ensure that the best interests of the DISTRIBUTOR are upheld at all times.

- The SUPPLIER will not enter into any commercial agreement with any party within the territory specified in article-2 for the purpose of promoting and/or selling any of the products listed in clause 3. It is clearly understood that the SUPPLIER cannot appoint any other distributor or sub-distributor within the territory specified in article-2 beside the DISTRIBUTOR to promote or sell any of the products listed in clause 3.
- The SUPPLIER will keep the DISTRIBUTOR informed with regard to New Product Launches and Advertising campaigns.
- The SUPPLIER shall provide all product training deemed reasonable and necessary, for the DISTRIBUTOR sales and technical team. Travel expenses will be on the DISTRIBUTOR's account.
- The SUPPLIER shall provide all relevant technical support to the DISTRIBUTOR
  to insure a smooth operation and performance towards the DISTRIBUTOR's
  commitments. This shall include the readiness of the SUPPLIER to send
  appropriate personnel to assist (if necessary) the DISTRIBUTOR's engineers in
  commissioning the first group of projects.
- Performance reviews, progress towards targets etc will be conducted quarterly by the SUPPLIER in coordination with the DISTRIBUTOR. This review will ensure full identification of known contracts and opportunities, performance against agreed targets and forecasting of future sales demand.
- The SUPPLIER agrees to confirm the delivery periods specified (As ex-works)
  based upon the receipt of an order this does not include the transport and
  the clearance times. Except as mentioned above, delays beyond dates
  specified in order acknowledgements are the SUPPLIERS responsibility. The

#### Scope:

On Feb 16,2018. Huili Testing Lab performed tests on pedestals to determine the pedestal axial load rating. The tests were performed in accordance with the above mentioned standard procedures. The pedestals were identified as 95x95x2.0mm Base having a vertical steel tube of 22.3mm diameter x 1.5mm wall thickness, assembled to a 75x75x3.0mm flat head plate welded with M18.3mm threaded stud.

#### Test Procedure:

Each STF1022 pedestal to be tested was aligned vertically in the test fixture. A load equal to the manufacturer's published axial load was applied to the test specimen. The imposed load was held for two minutes and then relaxed, the specimen was visually inspected for damage. The specimen was then loaded until failure. Three specimens of each pedestal type were selected at random for test program.

Said warranty is against latent defects in design or workmanship under normal working conditions, as directed by Dawn Modular Floor specifications in effect at the time of Installation, and the use of said materials and excluding Acts of Nature and provided that:
- a. The product have not been subjected to accident, misuse, abuse, neglect, deterioration by chemical action or damage during shipment not have been used for purpose other than for which they were designed.
- b. Buyer within thirty (30) days after discovery of defect, provides Dawn Modular Floor system with a reasonably precise written statement of the nature of the Buyer's claim.
